### **RELEASE OF LIABILITY**

The statements below are related to any service the client chooses to purchase or participate in from All Stage Canine Development, Inc.

All Stage Canine Development is providing a service to help teach the client to work with their dog on different levels with both behavior and obedience. There is no promise or guarantee of the stability of a dog's temperament or physical status as there are many variables that could affect any dog's physical or mental status.

Client understands a dog is an animal who contains free will. There is never any guarantee that the dog will perform its tasks 100% of the requested time.

Client agrees to notify All Stage Canine Development immediately about any behavioral or training concerns that are new during the training process.

All Stage Canine Development will not be held responsible for any potential damages that may occur during the training program or after. Damages can include but are not limited to; animal to animal bites, animal to human bites, damaged property, illness, or injury.

Client understands and agrees that the dog's behavior is subject to change under various levels of stimuli. This change can also lead to aggression towards an animal or person. All Stage Canine Development will not be held responsible for any damages that may occur as a result of aggressions from the dog.

All Stage Canine Development will not guarantee zero chance of aggression in any dog. Situations that could cause aggression could be, but are not limited to; excitement, fear, resource guarding, prey drive, dominance, and mistreatment. All Stage Canine Development will not be held responsible for any aggressive behavior or potential outcome of the behavior due to external and unpredictable circumstances.

High energy programs such as regulated play and agility can be rigorous and hard on all areas of the dog's body such as the limbs and joints. All Stage Canine Development will not be held responsible for any physical damages that could occur from rough play with another dog.

Any level of training or behavior modification will require continuous reinforcement of all trained behaviors. Client agrees to follow recommended training after completion of their program. Failure to provide additional training as instructed may result in a reduction of the quality of the dog's continued performance. All Stage Canine Development will not be responsible for any decrease in performance due to a negligence or failure to follow instructions.

Client agrees to never leave a child alone with a new dog. A dog's behavior can be unpredictable and can put a child at risk. Children's behavior can also be unpredictable which could cause uncertainty with a dog. All Stage Canine Development will not be held responsible for any potential damages resulting in behavior from the client's dog to a child.

Client agrees to feed all meals to their dog in an area protected away from children in order to prevent guarding behaviors. The dog should also be fed portions that are quickly finished, so there is nothing left in the bowl for the dog to linger over and guard. Empty bowls should be taken up and put away to prevent a guard of the feeding area.

Client must never allow a child to startle, awaken, or hug a sleeping dog. If the dog falls into a deep sleep, it is important to put the dog in another room or even a crate to prevent a possible safety hazard from the dog being startled.

Client acknowledges and agrees that either the dog, or the client could be considered unfit for the program they are enrolled in at any time and can be halted by All Stage Canine Development. Should this occur, past payments for services already provided are not refundable.

Client understands that a dog is an animal with free will and agrees that time and any change of conditions can alter the dog's ability or willingness to perform its job. Change of conditions can include but are not limited to physical, mental or medical changes, changes in the household, or changes in the daily routine.

Client understands they must provide current vaccines for any dog they may have participating in any program that All Stage Canine Development offers. This provides safety to employees, and clients.

Even though all other vaccines are not mandated, they are HIGHLY recommended since taking your pet into a high traffic area can drastically increase their exposure to contagious elements. These vaccines include Distemper, Bordetella, Parvo, as well as the Influenza Vaccine. Client also understands that all vaccines do not guarantee 100% protection when taking their dog into the general public. All Stage Canine Development will not be responsible for any illness from exposure to other dogs.
